JERSEY COAST SHARK ANGLERS 2022 FLUKIN' FEVER TOURNAMENT RULES

- At least one representative MUST attend the Captains' Meeting to register and receive all pertinent tournament information. All anglers are required to have the appropriate required NJ Salt Water Registry or Licenses applicable.
- Each boat is eligible to win ONLY ONE PRIZE OR ONE PLACE.
- Fishing may commence at 5:00am (honor system) on the scheduled tournament date.
- In case of a tie, the prize money will be split equally.
- VHF CHANNEL 72 WILL BE THE TOURNAMENT CHANNEL. VHF CHANNEL 65 WILL BE THE ALTERNATE. If any vessel/angler cannot reach a committee boat on either channel please call 732-773-3409 or 862-432-6814 for the tournament contacts.
- WEIGH-INS WILL BE BETWEEN THE HOURS OF 3:00pm and 5:00pm at Captain Bill's Landing on 1st day. Remainder of the month fish can be weighed in at any CERTIFIED SCALE. WEIGH SLIPS MUST BE ACCOMPANIED BY PICTURE OF FISH ON THE SCALE WITH CLEAR SIGHT OF WEIGHT AND SUBMITTED TO JCSA WITHIN 3 DAYS OF BEING WEIGHED VIA, TEXT, EMAIL OR DROPPED IN MAILBOX ON FRONT OF JCSA CLUB HOUSE 385 HERBERTSVILLE RD, BRICK.
- ALL FEDERAL AND STATE RULES AND REGULATIONS PREVAIL.
- ALL JUNIOR ANGLERS 17 AND UNDER FISH FREE WITH A PAID REGISTERED ADULT. FISH WEIGHED BY A JUNIOR MUST BE ACCOMPANIED BY THE ADULT THEY ARE FISHING WITH AND BOTH MUST SIGN THE WEIGH SLIP. JUNIOR PRIZES DO NOT INCLUDE CASH.
- Positively no transferring of fish between anglers and/or boat.
- All boats/anglers and crew fish at their own risk.
- All winners must submit their social security number and proper ID BEFORE THE PRIZES ARE AWARDED. They must fill out all paper work at the time of the awards and submit the same prior to receiving cash prizes. NO EXCEPTIONS.
- All fish shall be weighed in their natural state.
- Any protest must be presented to the Tournament Chairperson on the day of the alleged infraction. The Chairperson, Committee and Weigh Master shall serve as judge and all decisions will be final.
- JCSA may retain a certified MARINE BIOLOGIST TO ENSURE THAT EACH FISH HAS BEEN CAUGHT DURING THE TOURNAMENT HOURS AND THE METHOD OF CATCH WAS ROD AND REEL.
- If there is any alleged infraction or question about a winning fish the CAPTAIN/ANGLER will be asked to take a POLYGRAPH TEST AT THEIR OWN EXPENSE. If captain/angler refuses they will automatically forfeit the Place in the tournament and ALL MONIES WON.
- ALL TOURNAMENT COMMITTEE DECISIONS ARE FINAL.
- ALL FISH MUST BE CAUGHT IN NEW JERSEY WATERS and all anglers must obey current fishing regulations.
- THIS FORM MUST BE FILLED OUT and returned to JCSA 385 Herbertsville Rd. Brick NJ 08724 no later than the captain's meeting for the corresponding tournament.
- In the event no fish are weighed in, winners will be pulled from hat.
- All Calcutta money less 10% charitable donations to NJ Make a Wish St. Judes Childrens Hospital Carmelina Cares will be refunded if no eligible fluke are caught.
- Fish must be caught on same boat.
